#### 6 SIDEWALK SPOT REPAIRS/REPLACEMENT

#### 1. INTRODUCTION

The Town of Taylorsville is seeking quotes for repairs/replacement of sidewalk at 6 locations within the town. This Request for Quote (RFQ) is not to be construed as an offer, contract, or commitment of any kind; nor does it commit the Town of Taylorsville to pay any cost incurred by the bidder in the preparation of its quote.

#### 2. SUBMITTAL DEADLINE

Submittals must be presented no later than 2:00 P.M. on June 9<sup>th</sup>, 2025 to:

Quotes received after the date and time set for receiving quotes will **NOT** be considered. The Town of Taylorsville will **NOT** be responsible for misdirected quotes. Vendors should call the Town of Taylorsville at (828) 632-2218 to ensure receipt of their quote documents prior to the deadline listed above.

#### 3. CONTRACT AWARD

Quotes shall be considered by the Town of Taylorsville staff and board based on cost of procurement, contractor integrity, compliance with public policy, record of past performance, financial and technical resources, and the best overall value to the Town of Taylorsville. The Town of Taylorsville reserves the right to accept or reject any or all quotes, waive formalities in the quote, waive irregularities in any or all quotes, and make a quote award deemed to be in the best interest of the Town of Taylorsville.

## 4. SUBMITTAL REQUIREMENTS

Contractors must provide the Town of Taylorsville with their quote signed by an employee or officer having legal authority to submit quotes on behalf of the contractor. The entire cost of preparing and providing responses shall be borne by the contractor.

### 5. REQUIREMENTS AND SPECIFICATIONS

All bidders must have a minimum automobile and liability insurance policy of \$1,000,000 per occurrence as well as worker's compensation that meets the state's statutory requirements. A copy of the current policy must be attached to the bid sheet unless the Town of Taylorsville already has a copy on file.

## Work requested:

Location 1 – Replacement of 23 feet of removed sidewalk.

Location 2 – Replacement of 23 feet of removed sidewalk.

Location 3 – Replacement of 44 feet of removed sidewalk.

Location 4 – Replacement of 21 feet of removed sidewalk.

Location 5 – Replacement of 10 feet of sidewalk. Sidewalk is currently there but buckled at driveway cut. Sidewalk will be removed by town staff before repair work is started.

Location 6 – Replacement of 5 feet of curbing and sidewalk near sewer tap.


All sidewalks are 5 feet wide. Locations can be seen on the attached maps.
