TOWN BOARD MEETING – REGULAR MEETING

The regular meeting was opened for business by Mayor Holleman at 5:00 p.m. The invocation was given by Mayor Holleman.

A motion was made by Councilman Simms and seconded by Councilwoman Brown to approve the minutes as presented from March 5th, 2024 regular meeting and March 18th, 2024 special called meeting as presented. The motion was passed unanimously.

Open Forum:

There were no comments in open forum.

A motion was made by Councilman Simms and seconded by Councilwoman Odom to approve the lease agreement between the Town and Catawba ABC Board for the ABC Store building. The lease agreement is for 1 year instead of 3 years due to the possible re-location of the ABC store to a bigger building in the future. The motion was passed unanimously. A motion was made by Councilwoman Brown and seconded by Councilman Simms to approve the agreement between the Town and Alexander County for property collection with the annual collection fee being 3.5% for a 4-year term effective July 1, 2024 thru June 30, 2028. A motion was made by Councilwoman Brown and seconded by Councilman Bumgarner to approve the adoption of a Resolution authorizing the sale of certain personal property as surplus to the town. A brief description is as follows:
